FISCAL YEAR 2018/2019 BUDGET**

MARCH 27, 2018

The Shenandoah Town Council held a public hearing on Tuesday, March 27, 2018, beginning at 7:00 p.m., with Mayor Clinton O. Lucas, Jr., presiding.

The meeting began with the Pledge of Allegiance.

ATTENDANCE: Council Members present were: Mayor Clinton O. Lucas, Jr.; Councilmen Lynn Fox; Charles Jenkins; I. Michael Lowe; and Richard Pierce.

Council Members absent were: David Hinkle and Vice Mayor Kite.

Other Town Officials present were: Juanita F. Roudabush, Town Manager/MMC; Sarah Dean, Town Clerk; and Paul Davis, Chief of Police.

Citizens present were: There were no citizens present at this meeting.

Media Representatives: There were no media representatives present at this meeting.

CALL TO ORDER: Mayor Lucas opened the public hearing at 7:00 p.m. He stated the purpose of this public hearing is to discuss the proposed Fiscal Year 2018/2019 Budget for the Town of Shenandoah. He noted each member received a copy of the proposed budget for review. He also stated the proposed budget was advertised in the local newspaper, and a copy has been on display in the Town Office for the public to review.

Mayor Lucas inquired if there was anyone present to speak *for* the Fiscal Year 2018/2019 Budget?

No one present spoke for the proposed Fiscal Year 2018/2019 Budget.

The proposed FY 2018-2019 Budget includes increases in the following rates and fees: \$2.00 per month on water, \$2.00 per month on sewer, \$1.00 per month on residential refuse, and \$2.00 per month on commercial refuse. No increases in the real estate tax, personal property tax, and business licenses.
