Subject: HURCO Smoke Machine for Sewer Testing

Surface water infiltration is a major issue for our system as our daily flow goes up during rain events and one of the tools that is used to find sewer line breaks, illegal connections, and other homeowner pipe issues is a smoke machine.

Recent smoke testing was done in 2018 and then in 2024 with a machine being borrowed from Virginia Rural Water. Ideally, testing should be done yearly to find problem areas and again after fixes are done to ensure the issue was corrected.

Staying on top of this maintenance item will reduce water infiltration and extend the life of our treatment plant. By purchasing our own unit, we have the flexibility to do the testing on our schedule rather than waiting and hoping one comes available.

The Hurco Ripcord model is the same as the one borrowed in the past and performed well. I would like to purchase this unit direct from Hurco.
