The Proposed FY 2025-2026 Budget includes increases in the following rates and fees as authorized by the Code of Virginia §58.1-3010 and §15.2-2119: refuse increases from \$13.50 to \$14.50 per month residential and from \$26.00 to \$29.00 commercial, in accordance with the terms of the Town's refuse contract. NO increases in personal property tax, business license, vehicle license fees, real estate tax, meals tax, lodging tax, water rates or sewer rates. The proposed budget for FY 2025-2026 reflects an increase of .34% over the FY 2024-2025 budget.
