- **Item # 2** Page Valley Cycling provided information on the Tour of Page County Stage Race being held April 26-27, 2019. The first event, Twilight Street Sprints, will be held on First Street in Shenandoah on April 26, beginning at 4:30 pm.
- **Item** # 3 The Town of Luray invited Mayor Lucas and Council to their 20<sup>th</sup> Annual Arbor Day Ceremony being held at the Ralph H. Dean Recreation Park on April 27, 2019 at 1:00 pm.
- **Item #4** Mayor Lucas and Council received information on the Luray Earth Day 5K/1K on the Greenway being held on April 27, 2019 with the 1K beginning at 9:30 am and the 5K beginning at 10:00 am.
- **Item** # **5** Mayor Lucas and Council received information on the 3<sup>rd</sup> Annual Spring into Stanley event being held April 27, 2019 from 10:00 am to 3:00 pm at the Ed Good Memorial Park.

#### **COMMITTEE REPORTS**

#### WATER & SEWER

(Chairman Kite and Councilmen Jenkins and Lowe)

Town Manager Roudabush informed Mayor Lucas and Council Trumbo Electric has looked into the ongoing issues with pump #2 at the Sewer Plant and determined it needs electrical upgrades to function properly. She explained Shenandoah Valley Electric Cooperative has also checked for voltage spikes and found there are no spikes, but they did find harmonic distortions which could be a direct result of the old wiring in pump #2, or the generators starting up.

Following a brief discussion, a *motion* was made by Vice Mayor Kite, *seconded* by Councilman Pierce, to authorize payment up to \$3,000 to be taken from the Utility Fund Capital Outlay Sewer Plant budgeted line item for Trumbo Electric to relocate, rewire, and upgrade the electric in pump #2 at the Sewer Plant.

Mayor Lucas reported a potential water leak on Pennsylvania Avenue.

Chairman Kite inquired about Constable Construction's completion of the sewer line replacement project on Junior Avenue.

Town Manager Roudabush stated they are coming back to finish a small section soon.

The Council noted they are very impressed with Constable Construction's work.

Chairman Kite inquired about water at the sidewalk at the Elementary School.

Town Manager Roudabush explained after speaking to school representatives, it was discovered the water is being pumped out of the school's basement and is not resulting from a water leak.

#### STREETS & PUBLIC PROPERTY

(Chairman Kite, Councilmen Comer, Fox, and Lowe)

Councilman Jenkins expressed appreciation for Mayor Lucas and Town Manager Roudabush meeting with representatives from the Virginia Department of Transportation to get them to begin work in Town.

Town Manager Roudabush explained a list of requests was provided to the representatives as well as a ride around Town to show them the problem areas. She noted VDOT plans to begin work on the 602/Maryland Avenue Tunnel on May 6, 2019 and they are also planning to clean some of the streets and ditches throughout Town prior to the Memorial Festival.

Councilman Fox inquired about the Public Works employees plans to complete the gravel area at the Dog Park.

Town Manager Roudabush explained this project is on their list and will be completed as soon as possible. She noted VDOT also has the ditch beside the Dog Park on their list.

Chairman Jenkins inquired about the Town's progress on finding a new grocery store following the notice of Shenandoah Grocery's closing.

Town Manager Roudabush noted she is actively looking for a new grocery store and has been in contact with several places but has not received any confirmations yet.

Councilman Comer offered the assistance of the Shenandoah Industrial Corporation.

Town Manager Roudabush noted she can provide some contacts for the Industrial Corporation members to reach out to if they are interested in helping the Town bring in a new grocery store.

Mayor Lucas expressed appreciation for the Sullivan's 40+ years of service to the Town and noted he would like to purchase a plaque and hold a celebratory ceremony prior to the Shenandoah Grocery's official closing date.
