The meeting began with the Pledge of Allegiance.

COMMITTEE REPORTS

WATER & SEWER

(Chairman Kite and Councilmen Jenkins and Lowe)

Town Manager Roudabush presented Council with a quote from Trumbo Electric to install a well pump controller and upgrade the electric at the Twelfth Street Well, to allow the generators to operate properly.

There being no questions, a *motion* was made by Councilman Jenkins, *seconded* by Councilman Comer, to authorize Trumbo Electric to install a well pump controller and upgrade the electric at the Twelfth Street Well, at a cost of \$7,200.00, to be transferred from the utility capital improvement checking account to the utility checking account.

Town Manager Roudabush presented Council with an invoice from Fidelity Power Systems for a service technician having to come to the Twelfth Street Well to reset frequencies that were not correctly set by a previous service technician.

Town Manager Roudabush explained she plans to dispute the invoice; however, the Council will not meet again before the invoice is due and she is requesting authorization to pay the invoice if Fidelity Power Systems does not abate the bill.

There being no questions, a *motion* was made by Councilman Pierce, *seconded* by Councilman Fox, to authorize payment to Fidelity Power Systems of \$816.20, for work completed at the Twelfth Street Well, to be transferred from the utility capital improvement checking account to the utility checking account.

Councilman Fox suggested contacting Shenk's Services to determine if they have a location to dump large amounts of leaves for recycling.

Chairman Jenkins reported Public Works has been working hard to clean up debris at Big Gem Park prior to the Christmas Tree lighting.

Councilman Lowe inquired about the reasoning for the entrance gate being closed at Big Gem Park.

Town Manager Roudabush explained the entrance gate was closed while Public Works cleared the Park to discourage community members from dumping trash in the wood-only dumpster and for safety around the equipment stored at the Park.

Councilman Fox commended the Public Works Department for cleaning up the Dog Park.

Town Manager Roudabush reported the Page County Economic Development Authority has a vacancy for District 5. She noted the EDA meets the third Monday of every month at 5:30 pm in the Board of Supervisors Room.

Town Manager Roudabush explained representatives for the Industrial Development Authority must reside in Town.
