CORRESPONDENCE

#1 – Council received a memo from Councilman Pierce to consider hiring Curtis Conley as a full time Parks and Maintenance worker with a starting salary of \$25,000.00, with \$1,000.00 raise after obtaining his CDL License, and a 5% raise after passing his probation.

A *motion* was made by Councilman Lowe, *seconded* by Councilman Pierce, to authorize hiring Curtis Conley to full time Parks and Maintenance worker with a starting salary of \$25,000.00, with \$1,000.00 raise after obtaining his CDL License, and a 5% raise after passing his probation.

The memo stated Council would need to authorize funding for this position which could either be funded for 2 years using ARPA funds or transferring budgeted lines with the second year needing to be budgeted.

Councilman Jenkins suggested using Parks Salaries budgeted lines first and then use ARPA funds for the remainder of the fiscal year.

Councilman Pierce stated wages could only be paid with ARPA funds and not benefits.

Town Manager Roudabush stated both wages and benefits could be paid with ARPA funds, but the accounting software does not have the ability to show auditors the benefits coming out of ARPA funds.

Councilman Fox stated he thought this position was budgeted for this fiscal year.

Councilman Jenkins stated a part time position was budgeted for this fiscal year, not a full time position.

Vice Mayor Kite asked if this full time position would bring the Town back up to full staff?

Town Manager Roudabush stated this position would bring the Town back up for Parks staff and Mr. Conley will help Public Works in the Winter.

Councilman Fox asked what happened to the Public Works full time position budgeted in the past?

Town Manager Roudabush stated for more than four years the salary was absorbed into the General Fund since there was no mention to hire a full time Parks position by the Council until now.

Councilman Fox asked how much ARPA funds would be left after using the funds for this position?

Town Manager Roudabush stated Treasurer Cindy Breeden would have that information, once the Parks Salaries line item was used.

There being no other questions, a *motion* was made by Councilman Jenkins, *seconded* by Councilman Pierce, to authorize using Parks Salaries budgeted line item first and then use ARPA funds for the remainder of the fiscal year to fund the full time position wages.

WATER & SEWER

(Chairman Kite and Councilmen Jenkins and Lowe)

Councilman Jenkins stated the 12 inch line originally was thought to be not in use, is being used to service Junior Avenue East and West. The line then reduces down in size into a pressure reducing station feeding Eppard's Subdivision.

Councilman Fox stated he thought the Town had a study which said it was a stagnant line.

Town Manager Roudabush stated the people who did the study may have been told it was

stagnant because it was the understanding at the time, but it does show in maps the line is being used now and has always been connected to these other areas serving businesses and residences.

Councilman Fox stated the 12 inch line should be utilized more to help increase volume in other areas too.

Councilman Jenkins stated he, Town Manager Roudabush, Director of Public Works T. A. Pendleton and Chief Waste-Water Operator Trey Pendleton met with an Engineer yesterday and they seem to be well versed on how to proceed with all water and sewer lines.

Town Manager Roudabush stated an Engineer would need to review how new homes affect the water and sewer lines.

Councilman Jenkins stated the Engineers have computer programs which they can feed information to produce models/simulations for the Town.

Councilman Fox asked if contractors had contacted the Town about Maryland Avenue?

Town Manager Roudabush stated she had given the contractors hand drawn maps, but no contractors had responded. She noted the Town could use ARPA funds to have the Engineers draw up plans to help with Maryland Avenue's inflow and infiltration issues, and to bid this project out.

Councilman Fox stated Maryland Avenue needs to be a priority.

Town Manager Roudabush agreed Maryland Avenue's issues needed to be addressed.

Councilman Comer asked if an Engineer would be able to help?

Councilman Jenkins stated Engineers are well versed on water, sewer, and electrical problems and can use their computer programs to give the Town rough estimates on pricing for projects.

Council received a memo from Councilman Pierce to consider hiring Racey Engineering as the Town's On-Call Architectural and Engineering firm for one year, with the option for a three-year renewal.

Councilman Jenkins stated interviews were conducted by the Personnel Committee, Town Manager Roudabush, Director of Public Works T. A. Pendleton and Chief Waste-Water Operator Trey Pendleton on Monday, August 9, with 4 architectural and engineering firms.

Councilman Jenkins stated they were all capable firms, but the Racey was ranked the highest due to their proximity to the Town, their rate fees being the lowest, and they have more than adequate and qualified staff to fulfill the current needs of the Town.

Town Manager Roudabush stated there is no fee for the contract unless the Town decides to conduct a project and then a fee would be negotiated per project cost and another vote of Council

would be required at that time.

Councilman Lowe stated their primary job would be to draw up plans so the jobs could be bid out.

Councilman Jenkins stated Racey also has experience in researching grants for jobs.

Town Manager Roudabush stated Racey applied for and received multiple grants for the Luray bridge project.

Councilman Comer stated Racey has a good relationship with VDOT.

There being no questions, a *motion* was made by Councilman Jenkins, *seconded* by Councilman Pierce, to hire Racey Engineering as the Town's On-Call Architectural and Engineering firm for one year, with the option for a three-year renewal. There is no fee for the contract unless the Town decides to conduct a project and then a fee would be negotiated per project cost and another vote would be required at that time.

Councilman Jenkins stated Town Manager Roudabush knows the priorities of the Town includes the altitude valve at the Tenth Street tank, getting a hydraulic study done, the replacement of water and sewer pipe replacement or extensions, getting the new well online, etc.

Town Manager Roudabush stated the turbidity meter went out at the Twelfth Street well and needs to be replaced. Town Manager Roudabush had a quote from EI Technical Services in the amount of \$7,864.00 to replace the turbidity meters, plus labor.

Councilman Jenkins stated he thought the meters had already been replaced and were used models when installed back then.

Town Manager Roudabush stated no, they have been in use for at least 20 years.

Councilman Fox asked if the Town had to have a turbidity meters?

Town Manager Roudabush stated under Health Department regulations, a municipal well could

not be used without turbidity meters.

There being no other questions, a *motion* was made by Councilman Jenkins, *seconded* by Councilman Fox, to authorize the purchase of turbidity meters from EI Technical Services for the Twelfth Street well in the amount of \$7,864.00, to be paid from Utility Capital Outlay Water and Sewer Equipment budgeted line item.

STREETS & PUBLIC PROPERTY

(Chairman Kite, Councilmen Comer, Fox, and Lowe)

Councilman Jenkins asked if Hensil Good Paving had looked at the South section of Sixth Street?

Town Manager Roudabush stated they had looked, but have not given estimates.

Town Manager Roudabush stated Pettit's Paving will also be requested to give estimates.

Town Manager Roudabush stated there is still a connection that needs to be made on Sixth Street before Public Works can cold patch the street in this area.

Town Manager Roudabush stated cold patching causes pavement estimates to be higher because the pavers have to dig up the cold patch but provides for a smoother street until paving can be done.

Councilman Jenkins stated Racey Engineering could take a look at Junior Avenue and give suggestions on how to fix that section of road.

Councilman Jenkins stated a section of sidewalk on Virginia Avenue has buckled from tree roots. This section runs beside a home of a resident who has to use a wheelchair to access his vehicle. The family is having a hard time getting the wheelchair over the buckled concrete.

Town Manager Roudabush had 2 quotes from William D. Price Backhoe Service to remove old concrete, prep, and pour concrete for a new sidewalk. The first quote was for a 4 ft x 24 ft section in the amount of \$2,400.00. The second quote was for a 4 ft x 66 ft section in the amount of

\$4,700.00.

Councilman Lowe stated it would be more cost effective to have the 66 ft section fixed.

Councilman Fox asked if the tree was on the Town or on the resident?

Town Manager Roudabush stated it was on the right of way between the sidewalk and street.

Councilman Comer asked if VDOT would fix it?

Town Manager Roudabush stated VDOT would not fix it.

Councilman Fox asked if VDOT had put that sidewalk in?

Town Manager Roudabush stated the sidewalk predated the VDOT organization and was paid for by federal funds.

Vice Mayor Kite asked how big were the trees?

Town Manager Roudabush stated they were approximately 6 to 8 inches round.

There being no other questions, a *motion* was made by Councilman Jenkins, *seconded* by Councilman Lowe, to authorizing the replacement of a 4 feet x 66 feet section of sidewalk on Virginia Avenue in the amount of \$4,700.00, to be paid from General Fund Capital Outlay Street Improvement budgeted line item. Work will be completed by William D. Price Backhoe Service.

Chairman Pierce stated the Council received the July 2021 Monthly Budget for review.

Chairman Pierce asked if the Council would like to discuss allocating ARPA funds for organizations?

Councilman Lowe stated he would rather wait for the full Council to be together. (Note: Mayor Lucas was absent).

Councilman Fox stated he would rather wait until all the costs to get the new well online were in.

Councilman Comer stated Racey Engineering had worked with the Town of Stanley to get their new well online, so they should be a good resource for our new well too.

PARKS & RECREATION

(Chairman Jenkins and Councilmen Lowe and Pierce)

Chairman Jenkins announced the large chair at Shenandoah River Park and Landing has been painted brown. (This was a JMU surplus chair and cost just \$4.00).

Councilman Fox stated the gazebo at the Dog Park looks nice since Public Work re-shingled the roof and painted it brown.

Councilman Lowe asked if the duckweed in the Big Gem Pond had been treated?

Town Manager Roudabush stated it has not been treated and the new full time Parks and Maintenance worker will learn how to treat Big Gem Pond as part of his job.

Councilman Pierce asked if Town Manager Roudabush had priced bathrooms for WigWam Village?

Chairman Jenkins stated Racey Engineering would be able to use a computer program to give the Town estimates based on the square footage of the bathroom.

Chairman Jenkins stated the 2 shelters at WigWam need shingles too.

Councilman Fox stated a metal roof would be more cost saving due to its longevity.

Town Manager Roudabush stated a metal roof is much more expensive and since they already have some leftover shingles, they may use them for both shelters this time.

INDUSTRIAL, ECONOMIC DEVELOPMENT & PROCUREMENT

Chairman Jenkins stated Page County Economic Development (PCED) is looking into initiatives to have wait staff of local restaurants relay events to tourists who come into the restaurant.

Town Manager Roudabush stated the Town's restaurants are having a hard time finding workers and are having to close early or even close for the whole day, which is very concerning.

Chairman Jenkins stated PCED is also looking into ways to help local businesses with the lack of workers and to encourage current employees.
