## MINUTES TOWN COUNCIL TOWN OF SHENANDOAH JOINT PUBLIC HEARING REZONING REQUEST

## **JUNE 13, 2023**

The Shenandoah Town Council and the Shenandoah Planning Commission held a joint public hearing on Tuesday, June 13, 2023, beginning at 7:00 p.m., with Mayor Clinton O. Lucas, Jr presiding. The meeting began with the Pledge of Allegiance.

<u>ATTENDANCE</u>: Council Members present were: Mayor Clinton O. Lucas, Jr.; Vice Mayor William Kite; Council Members Denise Cave; Russell Comer, Jr.; Lynn Fox; I. Michael Lowe; and Richard Pierce.

**Planning Commission Members Absent**: There is one vacant position on the Planning Commission.

**CALL TO ORDER**: Mayor Clinton O. Lucas, Jr. opened the public hearing at 7:00 p.m. He stated the purpose of this joint public hearing is for a rezoning request of Superior Siding & Home Improvements, from Commercial to Residential (R2) on property located at corner of S. Second St & Pulaski Avenue, Shenandoah. This property is identified by tax numbers 102A6-1-82-1 through 4.

He noted if approved, this rezoning would allow for any items allowed as a matter of right and in compliance with Town Code Section 50-67.

Mayor Lucas inquired if there was anyone present to speak *for* the rezoning request?

James Shifflett, owner of Superior Siding & Home Improvements, stated he wanted to rezone these four lots to build four single-family homes.

Keith Sampson inquired as to whether a fence will be installed between these lots and AutoDealz; to which Mr. Shifflett replied he had not planned on it. Mr. Sampson stated he has safety concerns with kids running around all the cars while playing. He stated he would also like to see increased Police protection due to drivers ignoring the stop sign.

Mayor Lucas inquired if there was anyone present to speak *against* the rezoning request?

Dee Sampson asked about a limit on the number of people in the home.

James Shifflett stated they were to be single-family homes which would have three bedrooms each.

Mayor Lucas inquired if there were any questions by the Council or Planning Commission members?

Councilwoman Cave inquired as to how many homes were to be built.

James Shifflett stated there would be four lots, for four single-family homes.

<u>Closing of Joint Public Hearing</u>: There being no further questions, a *motion* was made by Vice Mayor Kite, *seconded* by Councilman Fox, to close public hearing at 7:06 p.m.
