- **#9 -** Town of Shenandoah Museum and Welcome Center Curator, Lora Jenkins reported 244 visitors to the Museum and Welcome Center in May. A breakdown of visitors included 52 visitors from the Model T Ford Club International's visit on May 14th; 58 visitors from Shenandoah Elementary School First Graders and Adults on May 19th; and 29 visitors on the Memorial Day Festival on May 27th, plus the month-long walk-ins.

Town Manager Roudabush stated the old unit is out of warranty. She stated it had been fixed while it was within the warranty, but immediately went out. It was then fixed once more and immediately went out.

A *motion* was made by Councilman Lowe, *seconded* by Councilman Fox, to go with Landes Heating & Air for replacing the heat/ac unit at the Sewer Plant with the funds to be paid from Utility Capital Outlay – Sewage Plant Budgeted Line Item in the amount of \$1,850.00.

Town manager Roudabush stated they are ready to start testing on the new well. She informed the Council Burner Well Drilling will start their 48-hour test as soon as their supplies come in.

She also noted the Town Crew have been busy fixing some water leaks around town.

STREETS & PUBLIC PROPERTY

(Chair Fox, Vice Mayor Kite, and Councilmen Comer and Lowe)

Chairman Fox inquired as to whether we have sent information to VDOT regarding the trees on Maryland Avenue.

Town Manager Roudabush informed him we have but have yet to hear back from them.

Chairman Fox also inquired as to the containers at the Old Batman House.

Town Manager Roudabush stated until she can get there, she cannot say whether he has room.

Councilman Comer asked what was in them.

Town Manager Roudabush stated she was unsure.

Councilwoman Cave inquired about a status update on William D. Price to clean out the ditch line between Sixth Street and Seventh Street.

Town Manager Roudabush said she will call and get an update.

Councilman Comer inquired about the newer building on property just before the entrance to the Tactical Walls building.

Town Manager Roudabush informed him the owner had planned on moving in his business of making dog friendly couches, but he has yet to purchase his business license.

Councilman Comer stated he knew of someone possibly interested in buying the building.

Town Manager Roudabush stated she would give Councilman Comer the owner's contact

information.

Chief Davis introduced Kevin Clem, the Town of Shenandoah's new full-time patrolman.

Town Manager Roudabush stated a meeting was held with Town, County, and State representatives to introduce the new owner(once it closes in July) of BoxCar Deli buildings and vacant lots. The new owner is very excited about the potential uses for the vacant lots and he is pursuing potential people to lease BoxCar Deli & Subs as a turnkey operation. The new owner is a builder/developer and does not have time for the restaurant, but he is actively pursuing a new tenant for it.

FOR THE GOOD OF THE TOWN

Amos Thomas asked about what was going on with South End Convenience.

Town Manager Roudabush informed him someone is renting the building, but they have not come in to get their business license.

Amos also inquired about getting a sign for the museum.

Town Manager Roudabush informed him that Museum Curator Jenkins is working with a few companies as far as designs and concept.

Amos asked about the old sign shop and if they have reopened anywhere.

Councilman Pierce informed him all their vehicles had been moved to Tactical Walls, but the business does not have an active license to operate.

Keith Sampson inquired about the Town Code for inoperable vehicles. He stated AutoDealz has a lot of them on the VDOT right of way.

Town Manager Roudabush stated we have spoken to the owner before about this issue. She stated she will follow up and talk to him about removing the inoperable vehicles.

Stephanie Richards made a statement about her appreciation of the steam engine that came into town last week. She stated it would be amazing for the kids if something like that could come here once a year.

Mayor Lucas stated Norfolk Southern does not like the complications of steam engines on the tracks.

Keith & Dee Sampson submitted concerns about a few things they have noticed in and around Town:

- a. The large number of inoperable vehicles, as well as the length of time they have been there, at AutoDealz.
- b. Multiple areas throughout town, on private property, with inoperable or unlicensed vehicles sitting around.

- c. Weeds and grass growing in sidewalks
- d. Lawns on private property needing to be mowed in multiple areas around Town
- e. As well as unsightly tree branches and logs laying in a yard on Route 340 just as you come into Town (near Marcus Street).

It was noted the Town writes letters to owners about mowing violations every Spring and Summer and will follow up with their other complaints.
